Annex 1 - Mandatory conditions

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence—
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
 - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
 - (b) in respect of premises in relation to—
 - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
 - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
 - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
 - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Annex 2 - Conditions consistent with the operating Schedule

PROMOTION OF LICENSING OBJECTIVES:

- a. General – All four licensing objectives:** Caretaker on site.
- b. Prevention of Crime and Disorder:** Caretaker and Staff on site. No alcohol. Children supervised by teachers. CCTV cameras in operation.
- c. Public Safety:** Fire extinguishers checked on annual contract. Electrical and Emergency Lighting checked annually by suitably qualified electrician. Emergency exits kept clear at all times. Maximum number of persons allowed in the Hall at any one time shall not exceed 400 people as advised by the fire authority.
- d. Prevention of Public Nuisance:** Staff on site. Isolated premises. Entertainment finished before midnight.
- e. Protection of Children from Harm:** Staff on site. No alcohol on premises. Children supervised by qualified teachers who are CRB checked.
