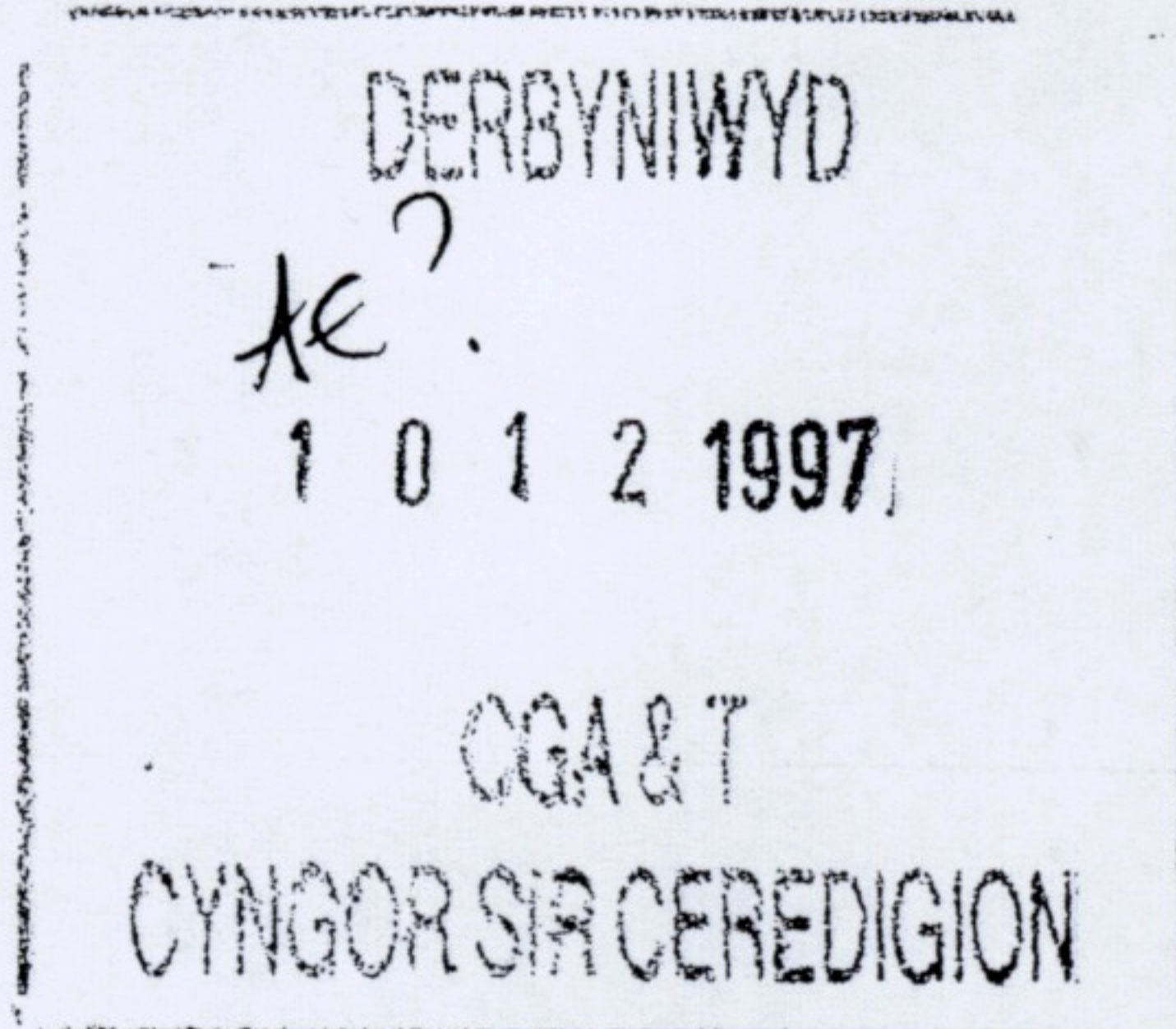

STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I WENDY HIGLETT DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since the eighteenth day of July 1988 the owner of the land known as Allt Cefn Maesllan, Llanarth, Ceredigion, more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the eleventh day of September 1997, I deposited with Ceredigion County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths no other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated the eleventh day of September 1997 referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

AND I MAKE this solemn declaration on the 1st day of December, 1997 conscientiously believing it to be true and by virtue of the Statutory Declarations Act 1835.

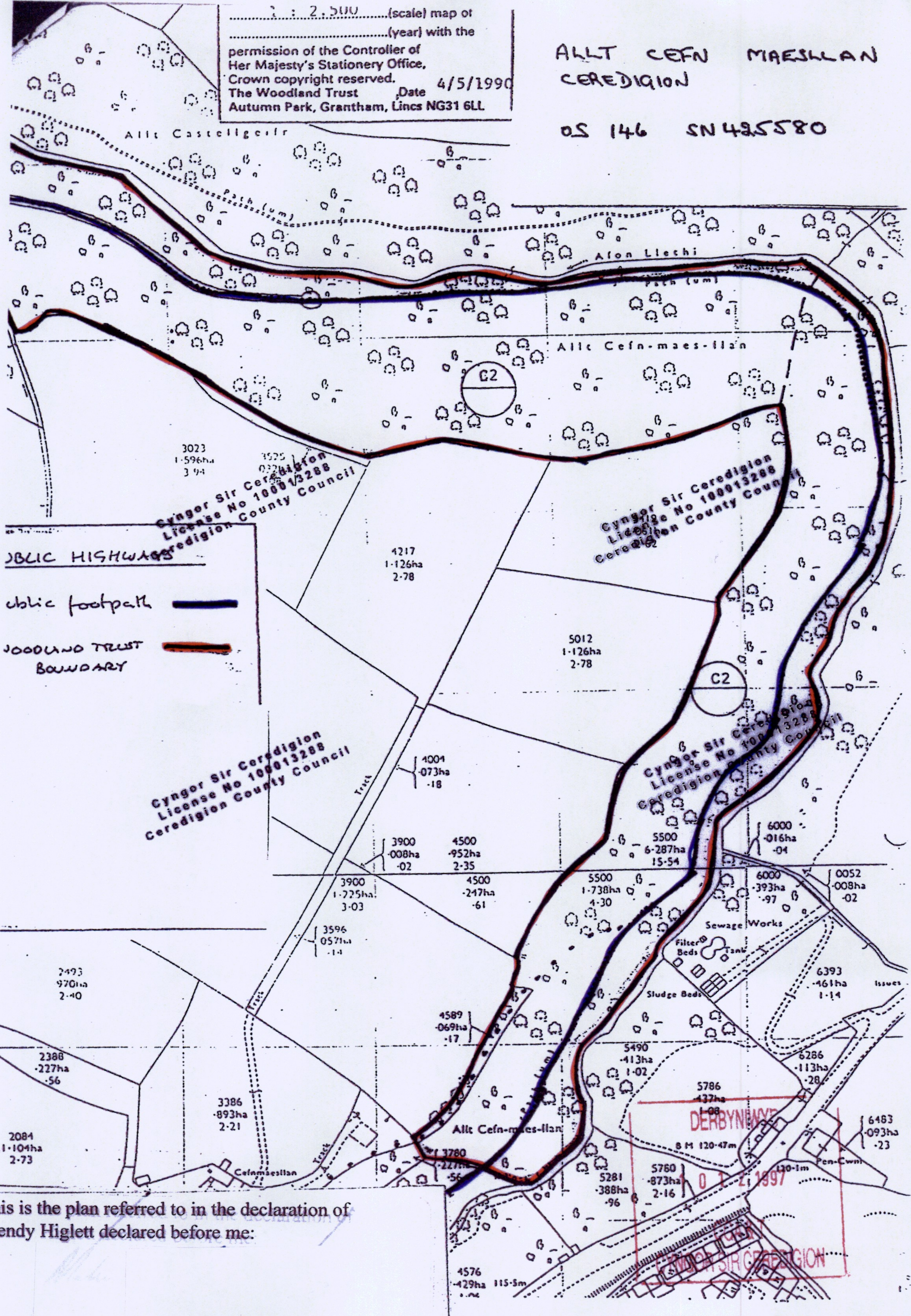

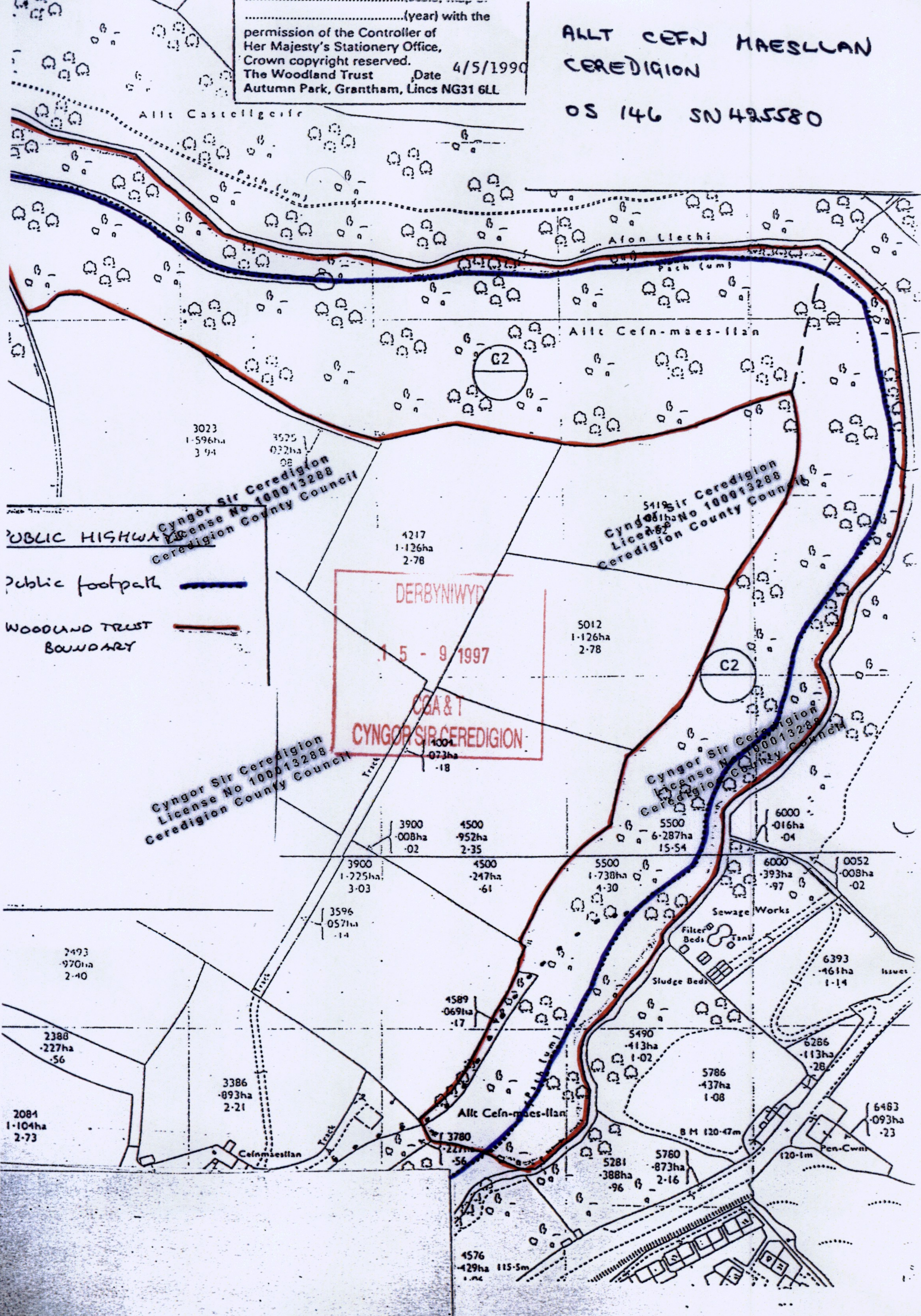
