## **Annex 1 - Mandatory conditions**

### **Mandatory conditions where licence authorises supply of alcohol**

- (1) No supply of alcohol may be made under the premises licence—
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

### **Mandatory condition where the premises licence includes a Condition that at specified times one or more individuals must be at the premises to carry out a security activity:**

- (1) Each such individual must be licensed by the Security Industry Authority.
- (2) But nothing in (1) above requires such a condition to be imposed—
  - (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c. 12) (premises with premises licences authorising plays or films), or
  - (b) in respect of premises in relation to—
    - (i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or
    - (ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act).
- (3) For the purposes of this section—
  - (a) “security activity” means an activity to which paragraph 2(1)(a) of that Schedule applies, and
  - (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

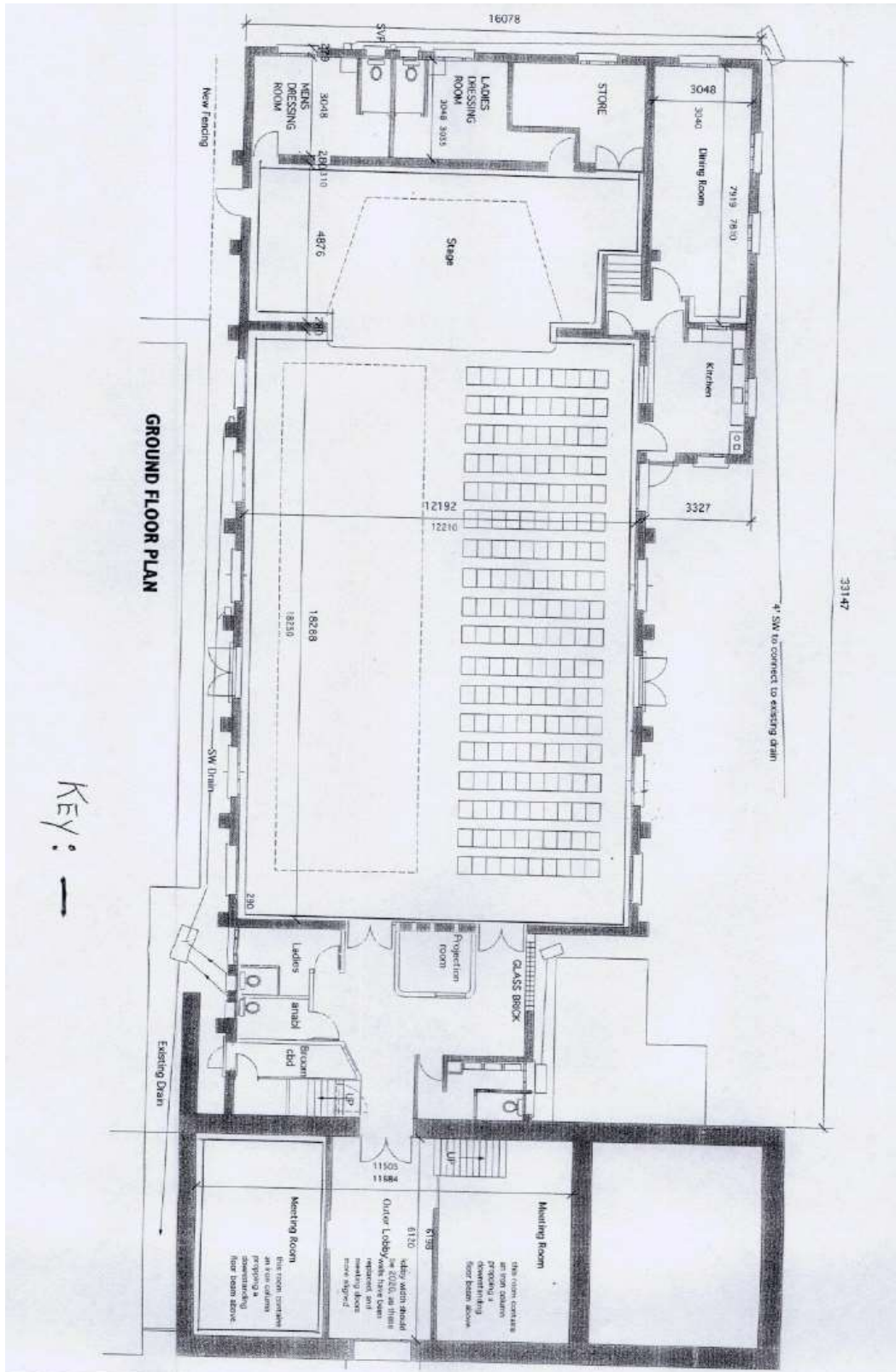
## **Annex 2 - Conditions consistent with the operating Schedule**

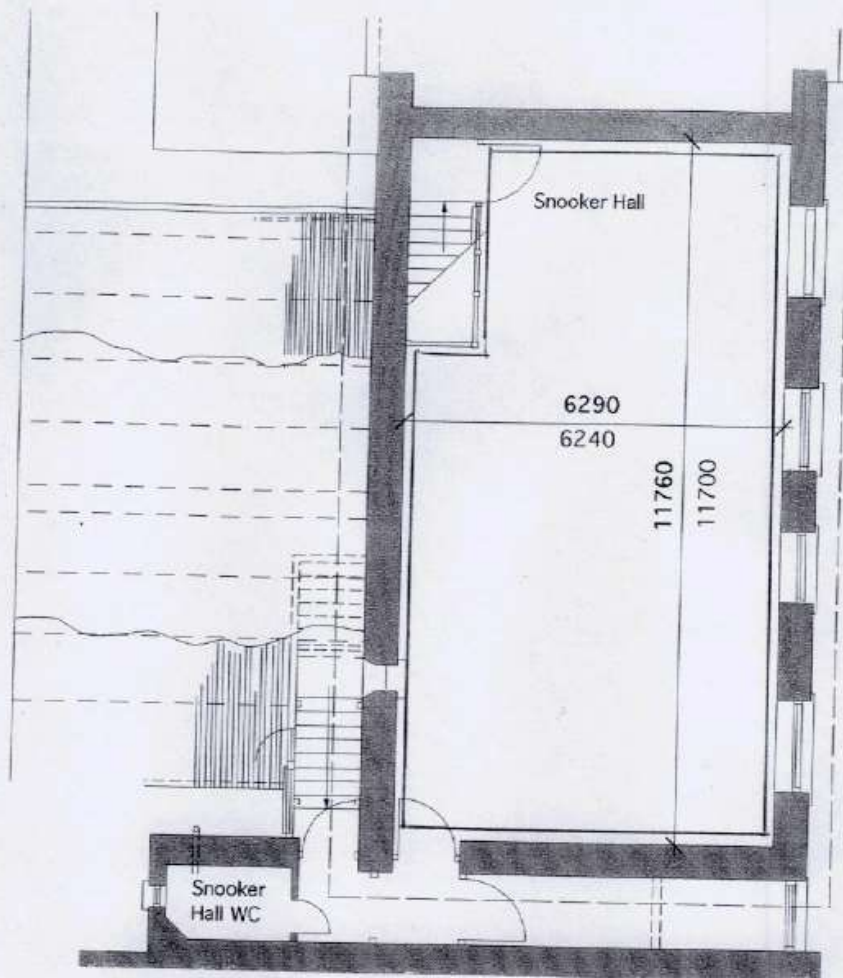
### **PROMOTION of LICENSING OBJECTIVES:**

- a. General – All four licensing objectives:** Care is taken to promote the Memorial Hall as an excellent Community venue. No alcohol is sold on the premises. A variety of groups hire the Hall, their ages from toddlers to senior citizens.
- b. Prevention of Crime and Disorder:** The nature of events held in the Hall do not normally attract crime and disorder – the Police would be informed of any such events.
- c. Public Safety:** The overall condition of the building is good with emergency lighting and well signposted exits. First aid box on premises and all fire fighting equipment checked annually. Public liability insurance in force and fire safety book completed each month.
- d. Prevention of Public Nuisance:** Care is taken that no amplified music is played too late as there are a few residential property near to the Hall.
- e. Protection of Children from Harm:** The Primary School use the Hall for concerts and dramas while the Mother and toddler group meet weekly. School children are supervised by their teachers, while parents are present in the toddler group.
