STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 22 January 1986 the owner of the land known as Waun Garthenor, Llangbi, Tregaron more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 12 day of May 1999 my predecessor deposited with Ceredigion County Council, being the appropriate Council, a statutory declaration stating that no additional ways had been dedicated since the deposit of the statement 19 May 1993.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statutory declaration referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

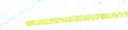
